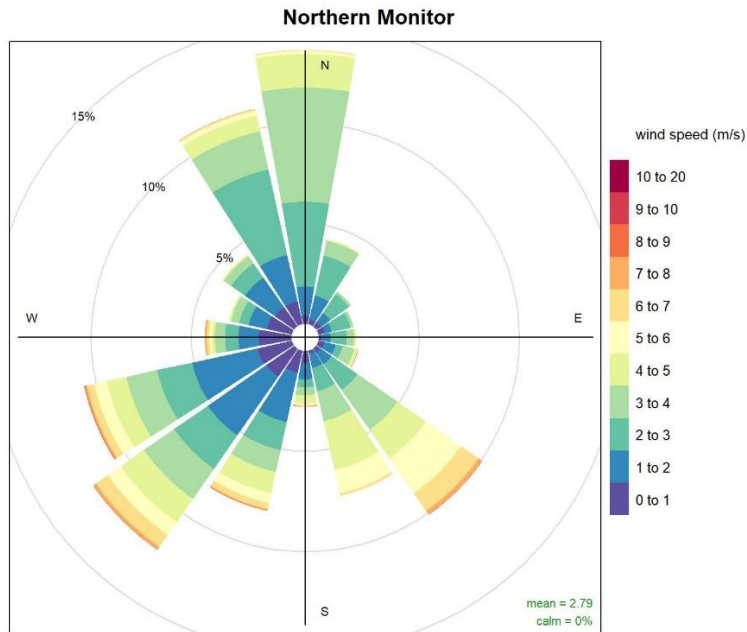

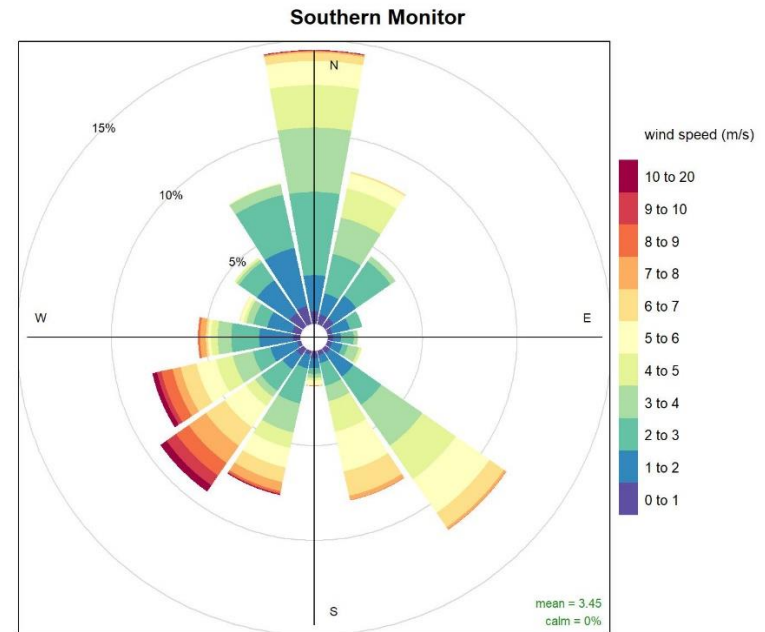


North Wind Rose – November 2025
